

## WAIVER

Released Parties includes Music City Rhythm & Rides LLC and its staff, agents, contracts, insurers, equipment suppliers, events sponsors, organizers, promoters, officials, property owners, and advertisers. Releasing Parties include the participants as well as the participant's spouse, children, parents, guardians, heirs, next of kin, and any legal or personal representatives, executors, administrators, successors, and assigns or anyone else who might claim or sue upon participant's behalf.

### Rules and Regulations

1. I Grant Music City Rhythm & Rides LLC permissions to use any photos and/or video of me for promotional purposes including, but not limited to use social media sites.
2. Any person arriving in an intoxicated condition shall not be allowed inside the bus.
3. If a passenger feels ill, request that the driver pull over immediately. Incidents are subject to an additional fees.
4. Liability for any damages to the vehicle which are caused by the passenger(s), will be charged additional fees.
5. If any illegal activates is suspected or occurs during service, Music City Rhythm & Rides LLC will terminate services immediately.
6. There is a zero tolerance policy for any physical or mental abuse to the driver.
7. There is a \$300 minimum charge for vomiting (or other bodily fluids) in the bus and \$100 if it gets only on the outside of the bus.
8. No hanging out the windows and yelling.
9. No one under the age of 21 can consume ALCOHOL AT ALL!
10. No standing in the windows or sunroof. Violators are subject to Tennessee Vehicle code. A \$100 charge plus any damages will be charged for tampering with the emergency exit or hanging out the windows (or throwing things out the windows).
